Owner Animal Safety Agreement

This Agreement is made by Howlll Films of Denver, Colorado and the client whose signature is below.

I (the "Client") represent that I am the legal owner of the animal, that the animal's vaccinations are current, and that the animal is properly licensed (if applicable). If the animal is a dog, I represent that the animal has not been exposed to distemper, rabies, or parvovirus within the past thirty (30) days.

I understand that my participation and involvement in the filming experience is a key part of accomplishing the agreed-upon goals and objectives.

I assume sole responsibility for the behavior of the animal and forever release, hold harmless, and indemnify Howlll Films, its officers, contractors, and other agents, from any harm or damage caused by me or my dog or to any person or persons or property at any time during filming. Furthermore, I expressly and irrevocably forever waive and relinquish any and all claims against Howlll Films except those arising from gross negligence on the part of Howlll Films.

I understand that Howlll Films is in no way responsible for the behavior of my animal during the filming experience.

All animals shall be controllable at all times. Depending on the situations, this could mean the animal is wearing a collar, secured in a fenced area, or other safety measures as determined by the filming location, animal type, and animal's socialization/training level.

Howlll Films does not permit the use of shock collars, prods, or electric stimulation devices during the filming process. Howlll Films strongly disagrees with the use of choke or prong collars and advise owners not to bring them on set.

If the animal appears aggressive, stressed and/or charges, threatens, or bites any person or animal, it shall be removed immediately from the filming location by the owner.

If at any time during the filming experience Howlll Films reasonably believes that the animal is ill, abused, exhibiting aggressive, fearful, compulsive, anxious, phobic, or any behaviors that may interfere or endanger the health and safety of any participants or bystanders, including the animal, I agree that Howlll Films may unilaterally end any filming session.

I acknowledge that dog bites must be reported to the local authorities as provided by law.

I will reimburse Howlll Films for any and all personal injury and/or property damage caused by my animal while with Howlll Films within five (5) business days of receipt of proof of such expenses. If I do not, I also agree to pay the maximum interest allowed by law and Howlll Films' reasonable collections and attorneys' fees.

Any controversy or claim arising out of or relating to this contract, or the breach thereof, or as a result of any claim or controversy involving the alleged negligence by any party of this contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his award, determine an award to the prevailing party of the cost of such arbitration and reasonable attorney's fees of the prevailing party.

This agreement represents the entire understanding between Howlll Films and me and supersedes any prior written or oral agreements. This contract can only be modified in a written document signed by both parties.
